Supply Chain


Our supply chain spans approximately 26 countries and comprises the network of entities and operations to secure for Manhattan Associates the products, services, and supplies required to conduct our business effectively. Our principal suppliers are providers of (i) IT and telecommunications hardware and services, (ii) facilities support, (iii) professional services such as legal, accounting, and marketing, and (iv) office supplies.

ANTI-SLAVERY and HUMAN TRAFFICKING PROGRAM

We are committed to ensuring that no slavery or human trafficking exists in any part of our business operations. Our Global Ethics and Compliance Manual, accepted by our employees around the world, expressly addresses slavery and human trafficking and emphasizes our policy of holding employees accountable for violations of our Global Ethics and Compliance Code. We train our employees on our Code at the time of hire and conduct periodic retraining. Under our Code, our employees are encouraged to seek guidance regarding compliance issues and required to report misconduct, and they may do so through several internal channels or by contacting our Compliance Reporting Line maintained on our behalf by a leading third-party reporting service.

Regarding our supply chain, as part of our corporate-wide risk mitigation efforts, we use an industry leading due diligence and risk screening service to pre-screen, and continually monitor, our market partners and selected vendors for compliance risk. We require our market partners to acknowledge our Partner Code of Conduct, which addresses slavery and human trafficking. We have adopted the practice of sending written communications to our partners and selected vendors at year end emphasizing our commitment to anti-slavery and human trafficking and requesting their similar commitment.
